"Accounting students' confidence with Excel" (Writing Results).

The paper is about Excel skills needed by new accountants and student confidence to use those skills.

"An Excel course for accounting students" (Planning).

This paper will cover how to implement a course in Excel skills for accounting (and business) students.

- "Cybersecurity Big Ideas to Infuse in Accounting Curriculum (unofficial title)" (Writing Results). The purpose of the study is to identify the most important cybersecurity topics to infuse into accounting curriculum using accounting-related certification examinations. The theoretical basis of this study is the Backward Curriculum Design Model.
- "Cybersecurity Curriculum Learning Objectives and Activities for Accounting Programs (unofficial title)" (On-Going).

The study's aim to to provide accounting educators with a framework and learning objectives that infuse cybersecurity-related learning goals throughout the accounting curriculum. Best practices are gleaned from a literature review of information security curriculum journals.

"Homebuilders' Response to Deteriorating Credit Quality" (On-Going).

This paper explores reasons for reactions to pending and actual downgrades to better understand firm financial policy. The study focuses on U.S. homebuilders in the wake of the contraction in the U.S. economy during 2007-09 to control for shocks that influence industry fundamentals. We ask if homebuilders actively manage leverage to maintain or achieve higher credit ratings in response to pending or actual ratings downgrades.

"Leverage Changes When Firms Strategically Reduce Debt" (Writing Results).

This paper examines how the source of cash influences the speed of adjustment to a leverage target. We focus on firms that prioritize debt reduction as part of a corporate strategy to approximate leverage management as a first-order concern. For a unique sample of 64 incidences of strategic debt reduction by non-financial U.S. firms between 1992 and 2012, we find that firms reduce debt primarily with operating cash flow. The average firm sheds 36% of long-term debt over 4.1 years, which results in average deleveraging of around 26%. The amount of operating cash flow needed to reduce debt requires multiple years to generate, which helps explain why leverage reduction is slow on average.

"Leverage Response to Credit Line Availability: The Case of Homebuilders" (Writing Results). This paper examines how the leverage of publicly-held, U.S. homebuilder firms responds to changes in bank revolving credit commitments over the business cycle. Prior studies suggest that revolving credit availability is reduced following a covenant violation, and covenant violations are associated with decreased leverage. However, covenant violations are required to be reported only when "uncured". We consider credit line commitment changes for any reason. We focus on homebuilders, firms with seasonal cash flows, a long cash cycle, and

widely use revolving credit lines. Average homebuilder revolving credit availability nearly triples from 2002-2006 and by 2010 drops nearly 100% from the 2006 peak. Empirical results suggest that leverage is positively related to revolving credit availability. Leverage and credit lines are sensitive to similar sets of fundamentals over the business cycle.

"Survey of Public Accounting Firms on Cybersecurity-related Services (unofficial title)" (On-Going).

Survey of current public accounting practitioners on their cybersecurity-related activities and services.

"Why Firms Strategically Reduce Debt" (Writing Results).

We study a unique sample of 73 incidences of intentional debt reduction efforts by non-financial U.S. firms between 1992-2012. We follow debt reduction effort to their conclusions through 2019. We document why firms initiate debt reduction, why it stops, how firms reduce debt, and the resulting leverage outcomes. Our results largely support theories of financial flexibility as the motivation to reduce debt.
