I have been a part of four AACSB site visits. In 2008 I was a faculty member; in 2013 I was an Assurance of Learning committee member; in 2017 I was a member of the Executive Committee charged with consolidating data and writing the report and served as a committee member charged with the application for initial Accounting accreditation; and, in 2021, I led the effort to consolidate all data and assure that the report was written to AACSB standards in

preparation for our site visit in Fall 21 to review both our Business and Accounting accreditations.

SACS-COC

As a faculty member I have collected and prepared reports for individual courses. As a Department Head I have prepared and submitted IERs and IEPs for the three majors within the department and have prepared and defended the Comprehensive Program Review for the department's majors. As Dean I have full responsibility for all of the College's reports.

Other accrediting agencies

During my work with the Provost on the University faculty resource allocation model, I became very familiar with the implications and limitations (such as class size or student/faculty ratios or course loads) imposed by accrediting bodies across the university and the need to respect these criteria. Additionally, when working with integrating business courses into other majors and creating dual degrees I was quite aware of the requirements of these other accreditation standards and worked to resolve any differences.

Diversity

Faculty

The number of female faculty in my department has tripled while the number of minority faculty has also increased substantially. Advertising of positions always includes The PhD Project as we seek to hire the best-qualified candidates. Overall, the faculty of the college is now over 35% female and over 35% minority.

Students

- o In Summer 2021 we launched the first Business Ethics Approaches for Teens (BEATS) Summer Boot Camp wherein we targeted potential FLI students in the local area to be paired with current BBA FLI students and faculty to expose participating teens to a cross-section of real-world ethical decision-making dilemmas faced by current and future business leaders.
- Fall 2014 to Fall 2020 the complexion of the College changed dramatically with respect to race, gender, and first-generation. The percent of females increased from 45% to 53%; the percent of minority students increased from 45% to 54%; and, the percent of first-generation students increased from 25% to 37%.

Community outreach

- A generous donation led to the establishment of the Copeland African-American
 Museum housed within the College. I spent many hours working with donors and
 contractors to create the space for the museum and have secured additional funding to
 annex and convert space for a reading room in the facility.
- Because food insecurity is an issue among college students, I work with a local church in their Grace Café which provides meals free of charge to any college student on Thursday nights during the school year (typically 190 to 200 students) and free snacks and drinks daily inside a comfortable study lounge.

Growth

New Majors

- The heathcare administration major started with zero students and no faculty and grew to over 160 majors and two full-time faculty in less than three years and has maintained that level for four years
- The online management major started with zero students and grew to over 170 majors in two years and has maintained that level.

Department and college

The number of majors within the department increased from less than 300 to over 700 in a 5-year period while the number of business majors increased from just over 1200 to more than 1700 in the same period.
